Full Terms and Conditions

1. In accordance with these **Terms and Conditions**, the company **Gorenje gospodinjski aparati d.d., Partizanska cesta 12, 3320 Velenje, Slovenia, with its below listed subsidized business units** (hereinafter "the Organizing parties") holds and presents the #simplymoments giveaway” (hereinafter “the Promotion”) Terms and Conditions.
2. This Promotion is only open for the residents with a permanent place of residence in the territories as follows: Bulgaria, Croatia, Czech Republic, Denmark, Finland, France, Germany, Hungary, Macedonia, Norway, Poland, Romania, Serbia, Slovakia, Slovenia, Sweden.
