

“Retro Velux EHF EURO 2020” Full Terms and Conditions

January 9th – 26th 2020

1. In accordance with these **Terms and Conditions**, the company **Gorenje gospodinjski aparati, d.o.o., Partizanska cesta 12, 3320 Velenje, Slovenia** (hereinafter “the Organizer”), holds and presents the “Retro Velux EHF EURO 2020” (hereinafter “the Promotion”) Terms and Conditions.
2. All natural persons who have an active profile on Instagram are allowed to participate. To participate, one has to post an EHF EURO 2020 moment photo or video on their Instagram feed or story and tag @Gorenjesimplifyfans or add #simplifyfans.
3. This Promotion is only open for the residents with a permanent place of residence in the territories as follows: Bulgaria, Bosnia and Herzegovina, Croatia, Czech Republic, Denmark, Finland, France, Germany, Hungary, Macedonia, Norway, Poland, Romania, Serbia, Slovakia, Slovenia, Sweden. In addition, this Promotion is only open to those aged 18 or over, excluding employees of the Organizer, their families, agents or anyone else professionally connected with this Promotion. It is the responsibility of the entrant to ensure the legality of entering this promotion under the laws of their country of residence.
4. The Promotion shall take place at @Gorenjesimplifyfans Instagram channel. Entrants can enter the Promotion between **January 9th and January 26th 2020** (Hereinafter: Promotion Period).

6. To enter the Promotion entrants must post photo or video with EHF EURO 2020 related content on their Instagram feed or story and tag @Gorenjesimplifyfans. Their profile has to be set on “public”.
7. With the creation of an Instagram account to enter this Promotion, the entrant agrees to the Instagram terms of use and privacy notice. The entrants that do not agree to such terms of use and privacy notice, shall not create an Instagram account or participate in the Promotion.

Additional entry details: Entrants must only participate with a video or photo that does not infringe or violate the rights of any third party, including but not limited to, ownership, copyrights, trademarks, patents, logos, licensing rights, rights of publicity or privacy or any other intellectual property rights.

10. All entries must be received by the end of the Promotion Period to be valid and no liability is accepted for illegible, incomplete or late entries.

19. The Organizer reserve the right to verify the eligibility of entrants. The Organizer may require such information (name, surname, address) as it considers reasonably
